ORDINANCE NO.36

General Nursing and Midwifery (GNM)

Three Years Program

Course & Faculty

1. This ordinance shall be applicable to General Nursing & Midwifery Diploma Program. This Program shall be run on Yearly system. The program is offered by the Faculty of Medical Sciences.

Duration

2. The duration of study of program shall extend over Three Years.

Intake & Fees

- a. The intake in the program shall be as per the approval granted by BOM from time to time. Subject to approval of Nursing Council (INC). At present it is 20 seats.
- b. The fees for this program will be decided by the university from time to time subject to the approval of regulatory authority/A F R C.

Academic Year

3. There will be one academic cycle every year, from July to June.

Eligibility

4. The eligibility for admission will be decided by INC and will change from time to time accordingly. However at present it is as follows.

1. Minimum education eligibility criteria for admission to GNM:

- 10+2 with English and must have obtained a minimum of 40% at the qualifying Examination and English individually from any recognized board. Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government. However Science is preferable.
- 10+2 with English having 40% of marks in vocational ANM course from the school recognized by Indian Nursing Council.
- 10+2 with English having 40% of marks in Vocational Stream Health care Science from a recognized CBCE board/State/Center.
- Registered ANM with pass mark.

2. *Reservation*

- a) For disabled candidates: 3% Disability reservation to be considered with a disability of Locomotors to the tune of 40% to 50% of the lower extremity and other eligibility criteria with regard to age and qualification will be same as prescribed for each nursing programme.
- b) 50% of total marks is relaxed for SC/ST candidates
- c) Any other reservation as per the State Govt.

Note: Reservation shall be applicable within the sanctioned number of the seats by INC and not above it.

3. Admission of students shall be once in a year.

4. Students shall be medically fit.

5. Minimum age for admission will be 17 years. (as on 31 December of that (Year) the upper age limit is 35 yrs.

Admission Procedure

1. Admission under these courses will be done as follows.
 - a. The University will issue admission notifications in news papers, and on the University's website, notice board of the university and other publicity media before the start of every cycle.
 - b. List of Candidates provisionally selected for admission/shortlisted based on merit will be displayed on the notice board of the University/University's website/or the students will be informed directly of their admission after the last date of application.
 - c. The candidates whose results of the qualifying exam are awaited can also apply, they will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet/School/College certificates. As a proof for required eligibility criteria before the due date failing which, the provisional admission cannot be granted. The candidate so admitted shall have to present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.
 - d. If a candidate the provisionally under (C) above could not obtain the marks to fulfill the requirements of eligibility criteria of the admission the provisional admission granted to him/her will be cancelled.
 - e. The application from may be rejected due to any of the following reasons:
 - (1) The candidate does not fulfill the eligibility conditions.
 - (2) The prescribed fee is not enclosed.
 - (3) The application form as not signed by the candidates and his/her parent guardian, wherever required.
 - (4) Supporting documents for admission are not enclosed.

- f. Enrollment/Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
- g. Admission rules as framed by the University shall be applicable for all admission from time to time.

Course Structure

The Course structure and syllabus as decided by INC from time to time.

Medium of Instruction and Examinations

The medium of instructions and examinations shall be English.

Examinations Scheme

- (a) Since the examination are conducted by INC not by university, The examination scheme will be decided by Indian Nursing Council.
- (b) No candidate shall be allowed to take the term end Examination unless one has:
 - (i) Attended at least 75% of lectures/practical delivered.
 - (ii) Paid all the fees due
 - (iii) Obtained 'No Dues' certificate from the concerned Department/college.
 - (iv) Submitted the job internship certificate/project Report, as notified in the syllabus.
 - (v) Received in-plant training/laboratory/Hospital as prescribed in the syllabus.

Clause (i) above shall not be application of theory/practical

Each student shall have to appear in the examination of theory/practical and continuous comprehensive examination system (CCE)/ internal assessment will be held in the manner prescribed from time to time by the University.

Promotion of Next Year & Failed Candidates

Passing criteria and promotion to next year will as decided by INC

Award of Credits and Grades

As Awarded by INC

Examination Centers

University examination centers will be notified by the university

General

1. In matters of admission, attendance, examinations and in all other matters not provided in this ordinance, the courses shall be governed by the provisions of the relevant ordinances of the same in the University so far as they are not inconsistent with the provisions of this ordinance.
2. In case of any dispute/ambiguity, the ruling of the Vice-Chancellor shall be final. However on the recommendations of the Academic Council the Vice-Chancellor shall be competent to change the System pattern of the examination.
3. In case of any dispute, the matter shall be decided under the Jurisdiction of District Court, Bhopal.

ORDINANCE NO.37**Master of Public Health (MPH)****Four Semester (Two Years) Program*****Course & Faculty***

1. This ordinance shall be applicable to Master of Public Health Post graduate degree program. This program shall be run on Semester system. The program is offered by the Faculty of Medical Sciences.

Duration

2. The duration of course of study shall extend over Four Semester (Two years).

Intake & Fees

- a. The intake in the program shall be as per the approval granted by BOM from time to time. At present it is 60 seats.
- b. The fees for this program will be decided by the university from time to time subject to the approval of regulatory authority/AFRC.

Academic Year

3. There will be one academic cycle every year, from July to June.

Eligibility

4. Candidate seeking admission in the first year of MPH. Program must have been awarded any of these degrees by any recognized university, MBBS, BAMS, BHMS, B.D.S, BMMS.

Admission Procedure

5. Admission under these courses will be done as follows.

- a. The University will issue admission notifications in news papers, and on the University's website, notice board of the university and other publicity media before the start of every cycle.
- b. List of Candidates provisionally selected for admission/shortlisted based on merit will be displayed on the notice board of the University/University's website/or the students will be informed directly of their admission after the last date of application.
- c. The candidates whose results of the qualifying exam are awaited can also apply, they will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet/School/College certificates. As a proof for required eligibility criteria before the due date failing which, the provisional admission cannot be granted. The candidate so admitted shall have to present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.
- d. If a candidate the provisionally under (C) above could not obtain the marks to fulfill the requirements of eligibility criteria of the admission the provisional admission granted to him/her will be cancelled.
- e. The application from may be rejected due to any of the following reasons:
 - (1) The candidate does not fulfill the eligibility conditions.
 - (2) The prescribed fee is not enclosed.
 - (3) The application form as not signed by the candidates and his/her parent guardian, wherever required.
 - (4) Supporting documents for admission are not enclosed.

- f. Enrollment/Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
- g. Admission rules as framed by the University shall be applicable for all admission from time to time.

Course Structure

6. The curriculum of each course shall be recommended by the concerned Board of Studies/faculty and approved by Academic council of the University. The Academic council of the University on the recommendation of the concerned Board of Studies/faculty may change number of papers and/or marking scheme of the course after the due approval of vice chancellor.

Medium of Instruction and Examinations

7. The medium of instructions and examinations shall be English.

Examinations Scheme

8. The examination scheme will be recommended by Board of studies and approved by Academic council.

9. No candidate shall be allowed to take the term-end Examination unless one has:

- (i) Attended at least 75% of lectures/practical delivered.
- (ii) Paid all the fees due
- (iii) Obtained 'No Dues' certificate from the concerned Department/college.
- (iv) Submitted the job internship certificate/project Report, as notified in the syllabus.
- (v) Received in-plant training/laboratory/Hospital as prescribed in the syllabus.

Clause (i) above shall not be application of theory/practical

10. Each student shall have to appear in the examination of theory/practical and continuous comprehensive examination will be held in the manner prescribed from time to time by the University.

- (a) For passing the examination; the candidate will be required to secure at least D grade in University examination separately in the term-end Theory, practical and Internal Assessment in each of the prescribed paper.
- (b) There will be an external examiner to evaluate the project report. The minimum passing marks for project work will be 50%

Promotion of Next Year & Failed Candidates

- (a) A candidate who have been admitted in 1st Semester will be promoted to 2nd Semester, automatically.
- (b) A candidate who have passed all the courses first and second semester OR have failed together will be promoted to Third semester (ATKT).
- (c) Deficiency up to five marks can be condoned to the best of the advantage of the student for passing the examinations. The deficiency can be condoned is not more than two subjects (theory and practical) of the same subject shall be considered as two separate subjects, for the purpose of awarding grace marks) in a each semester.

Award of Credits and Grades

11. Each course, along with its weightage in terms of units and equivalent credits, shall be recommended by the concerned Board of Studies and shall be approved by the Academic Council. Only approved can be offered during any year.
12. The distribute of weightage/marks for each component shall be decided by the respective Board of Studies/faculty and approved by academic Council, of the University subject to such stipulation as given under:
13. A student shall be continuously evaluated for his/her academic performance in a subject through tutorial work, practical, home assignment, mid-year tests, field work, seminars, quizzes, end-year examinations, hospital training and regularity, as proposed by respective Board of Studies.faculty and approved by Academic Council of the University.
14. For the award of degree minimum Cumulative Grade Point Average (CGPA) required is 5.0.

15. In each year, there will normally be three mid-year tests including PUT for theory block. Only in emergent cases number of tests could be reduced to two with approval of the Vice Chancellor.

16. Each student, registered for a program, shall be awarded grade by the university for the specific subject/paper. The grades awarded to a student shall depend upon his continuous evaluation through performance in various examinations, assignments quizzes. Laboratory work, class work, mid-year test, end year exam and regularly. The grades to be used and their numerical equivalents are as under:

18. The year Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA) shall be calculated as under:

Where C_i is the number of credits offered in the i th Subject of a Year for which YGPA is to be calculated, p_i is the corresponding grade point earned in the i th subject, where $i=1,2,\dots,n$, are number of subjects in that year.

Here NC_j is the number of total credits offered in the j th year, YG_j is the YGPA earned in the year, where $j=1,2,\dots,n$, are number of year in that course.

Award of Division

19. Division shall be awarded only after the 4th year for candidates after completing final year examination based on integrated performance of the candidate for all the four years as per following details.

Merit Lists

21. Merit list of first 10 candidates in the order of merit shall be declared at the end of each year from amongst the candidates who have passed in one attempt.
22. Final merit list shall be declared by the University only after the main examination final semester on the basis of the integrated performance of all the two years. The merit list shall include the first ten candidates securing at least First division and passing all semester in single attempts.

Maximum Duration of Completion of Program

23. A candidate has to complete the entire course of post graduate degree within a maximum period of four years from the session of first admission.

ORDINANCE NO. 38**TWO YEARS PARAMEDICAL DIPLOMA COURSE*****Aims***

To Provide skill oriented training to the students and thus to provide skilled technicians who will be able to work various Paramedical sectors.

Objectives

- To impart adequate theoretical and practical knowledge required for the paramedical technician.
- To enable the student to perform various routine paramedical techniques and practices. This ordinance shall be application for two years Paramedical Diploma Courses.
- The first Paramedical Diploma of Two Years courses. Hereinafter called 2 – YDC, shall be designed as Diploma in Paramedical, in respective Branch.

The ordinance shall be applicable:

- a. Diploma in O.T. Technology
- b. Diploma in Dialysis Technician
- c. Diploma in X-Ray Radiographers
- d. Diploma in Cath-Lab Technician
- e. Diploma in Paramedical Ophthalmic Assistant
- f. Diploma in perfusionist Cardiac Surgery Technician
- g. Diploma in Medical Laboratory (DMLT)
- h. Diploma in Optometric- Refraction
- i. Diploma Anesthesia Technician
- j. Diploma in Medical Record Science
- k. Diploma in Clinical Biochemistry
- l. Diploma in Yoga
- m. Diploma in Pharmacy (Ayurved)

Academic Year

There will normally be one academic cycle for this program every year starting from July to June.

Academic Qualification and Selection criteria for admission

- Minimum qualification for admission to the paramedical certificate course shall be the Qualifying Higher Secondary School Certificate Examination (10+2) with Science, Physics, Chemistry, Biology and Mathematics from M.P. Board of Secondary Education or 12th standard 2 years P.U.C. or equivalent examination from a recognized Board/University.
- For SC/ST/Other Category Candidate. The seat will be reserved as per provision of M.P. Govt. Norms as amended time to time. Other norms laid down by State Council of Paramedical Courses shall also be followed.
- The candidate should have completed minimum of 17 years of age on / before 31st of the concerned academic session.
- Section Criteria: The admission in Paramedical Diploma Program First year shall be based on the merit of the qualifying examination.

OR

The candidates whose results of the qualifying exam are awaited can also apply, who will be admitted provisionally. Such candidates, however, must produce the previous year Mark Sheet/School/College certificates, as a proof for required eligibility criteria before the ~~due date~~ failing which, the

provisional admission cannot be granted. The candidate so admitted shall have to present Mark Sheet/Grade Sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.

The application form may be rejected due to any of the following reasons:

- The candidate does not fulfill the eligibility conditions.
- The prescribed fees are not enclosed.
- The application form is not signed by the candidate and his/her parent guardian, wherever required.
- Supporting documents for admission are not enclosed.
- He/ She is found to have produced false/forged documents or found to have used unfair means to secure admission.

OR

- He/ She is found involved in serious breach of discipline.

Admission rules as framed by the University shall be application for all admissions from time to time.

Common Entrance test (CET), conducted by the University or any designed agency.

Number of Seats

Number of seats will be as per course approved by competent authority.

Fee Structure

The Fees for each course shall be decided by Board of Management of University as approved by Regulatory Commission/Competent authority.

Curriculum and syllabi

The curriculum and syllabi will be framed by concerned Board of Studies which duly approved by academic council in accordance with the guidelines issued by concerning.

Commencement of Courses

- The Course shall be commencing from the month of August/September of every academic Year.
- The subjects to be studied in the academic year if the Paramedical Diploma programs shall be as per the scheme, approved by Academic Council of the University.

Medium of Instructions and Examinations

The medium of instructions and examinations shall be either English OR Hindi.

Promotion to Higher Year

A candidate who has been admitted in the Diploma course will be promoted to higher class in accordance with the following sub rules:-

- Candidate falling in any number of subjects (Theory or Practical) will be permitted to appear in supplementary examination to be held every year.
- Candidate falling in maximum two subjects (Theory or Practical) will be admitted higher year, i.e. he/she will be allowed to appear next examination keep term.
- A Candidate falling in more than two subjects after supplementary exam result (Theory or Practical treated separately as a subject) will be treated fail and will appear in next yearly examination as ex-student.

ORDINANCE NO.39
POST BASIC B.SC. NURSING
ANNUAL SYSTEM (TWO YEARS) PROGRAM

Course & Faculty


This ordinance shall be applicable to Post Basic B.Sc. Nursing degree program. This program shall be run on Annual system. The program is offered by the Faculty of Nursing. The Bachelor or Under Graduate Degree is of two-year program consisting of classroom teaching, self academic activities and clinical posting. The department of Nursing assume responsibilities as professional, competent nurses and midwives at basic level in providing promotive , preventive, curative and rehabilitative services .

Make Independent decisions in nursing situations ,protect the rights of and facilitate individuals and groups in pursuit of health ,function in the hospital, ,community nursing services ,and conduct research studies in the areas of nursing practice . They are also expected to assume the role of teacher ,supervisor and manager in a clinical/ public health settings

Nomenclature

The Degree in nursing two year course here in after will be designated as Post Basic Bachelor of Science in Nursing in short "Post Basic B.Sc. (Nursing)".

Goals of Course:

Maximum Duration of Completion of Program

The duration of the certified study for Post Basic B.Sc Nursing shall be full time regular course and its duration shall extend over a period of two continuous academic Years' on a full time basis for the award of the degree. ***The student for the award of the Post Basic B. Sc. Nursing degree need to complete the course by passing in all mentioned subjects in the courses within a period of maximum Four Years or minimum of Two Years from the date he/she joined the course..***

Intake & Fees

- a. The intake in the program shall be as per the approval granted by Regulatory bodies or statutory bodies from time to time.

VARIOUS COURSES UNDER INDIAN COUNCIL OF AGRICULTURAL

101.2 Faculty Name : Faculty of Veterinary Science.

101.3 Course Name : Diploma in Veterinary Science

101.4 Duration of the Course: The provisions of this ordinance shall apply to the Two years/ four semester Diploma in Veterinary Science
The maximum duration for completing the Diploma Veterinary Science Programme for regular students shall be Eight Semesters.

101.5 Eligibility for Admission: -

12th Pass PCB /P,C, Biotech. / Agriculture with General 50% ST/SC/OBC 45% or Entrance Exam Conduct by University or Central Government or State Government.

101.6 Eligibility for Admission to NRI/ Other Privileged Candidates: -

Non-Resident Indian & other privileged candidates shall be eligible for admission to the course for accordance with the directives of Govt. of India and or State Government.

101.10 Medium of Instruction & Examination: -

The Medium of Instruction during the Examination shall be English/ Hindi.

101.11 Examination: -

Examination will be conducted as per Ordinances Number 5 of Mahakaushal University, Jabalpur (M.P.) as per the Regulations made in this respect as described in the Scheme of examination promotion to subsequent semesters and course of studies shall be as per the recommendation of the concerned Board of Studies with due approval of Academic Council.
