No. A-4369.— In exercise of the powers conferred by Articles 225 of the Constitution of India, Section 54 of the States Reorganisation Act, 1956, clauses 27 and 28 of the Letters Patent, the High Court of Madhya Pradesh, hereby, makes the following amendments in the High Court of Madhya Pradesh Rules, 2008, which shall come into force from the date of notification in the Madhya Pradesh Official Gazette.

## AMENDMENTS

1. In chapter VII,
  - (i) In sub- rule (1) of Rule 1, the figure "10.15" shall be substituted by the figure "10.30".
  - (ii) In sub- rule (1) of Rule 1, the figure "2.15" shall be substituted by the figure "2.30".
  - (iii) In sub- rule (2) of Rule 1, the figure "9.45" shall be substituted by the figure "10.00".
2. In Rule 14 of Chapter XI, the figure "10.15" shall be substituted by the figure "10.30".
3. In sub-Rule (1) of Rule 7 of Chapter XII, the figure "10.15" shall be substituted by the figure "10.30".
4. In Rule 3 of Chapter XVIII, the figure "10.15" shall be substituted by the figure "10.30".
5. In Form No. 15, the figure "10.15" shall be substituted by the figure "10.30".
6. In Chapter XII, in Rule 1, after sub-rule (5), the following sub-rule shall be inserted;
  - "(6) Any main case, interlocutory application or any other document in a main case is e-filed then such main case shall be listed before the concerned bench as soon as possible, not later than 7 working days from the date of filing, subject to removal of defaults & pointed out by the Registry, if any."
7. In Annexure (Subject Category Code), after Subject Category Code 18608, the following Subject Category Code shall be inserted;

"18609 GST Tax Appeal"
