F. No. 3369-XXI-B (One)-2024.—Whereas, in compliance of the directions made by Hon'ble Supreme Court of India in WP (C) 643-2015. All India Judges Association Vs. Union of India and others, dated 27th July, 2022 and 19th May, 2023 and in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in consultation with the High Court, the Governor of Madhya Pradesh, hereby, makes the following amendments in the Madhya Pradesh Higher Judicial Service (Recruitment and Conditions of Service) Rules, 2017, namely:—

#### **AMENDMENTS**

In the said rules.-

- In rule 2, in clause (e), for the words "Additional District Judge", the words "District Judge" shall be substituted.
- In rule 3, after the word 'under': and before the table the 2. following clauses shall be inserted, namely:-
  - District Judge (Entry Level) (in Pay Scale Rupees "(a) 1,44, 840-1,94,660 Level J-5).,
  - District Judge (Selection Grade) (in Pay Scale Rupees (b) 1,63, 030-2,19,090 Level J-6).,
  - Principal District Judge (Super Time Scale) (in Pay Scale (c) Rupees 1,99, 100-2,24,100 Level J-7)., The pay scales provided above shall be revisable from time to time.".
- In rule 4, in the first proviso, for the figures, "65%, 25% and 3. 10%", the figures "50%, 35% and 15%" shall be substituted respectively.
- In rule 9, for sub-rule (5), the following sub-rule shall be 4. substituted, namely:-

There shall be no deemed confirmation.".

- In rule 11, in sub-rule (4), for clause (b), the following clause 5. shall be substituted, namely :-
  - The Seniority, of person promoted through limited "(b) competitive examination of Civil Judges (Senior Division) under clause (b) of sub-rule (1) of Rule 5 shall be fixed in the order of merit in the selection list.".

In rule 11, for sub-rule (5), the following sub-rule shall be 6.

substituted, namely:-

- "(5) The seniority of the members of the service promoted under clause (a) of sub-rule (1) of Rule 5 of the HJS Rules, 1994 shall be as per the seniority in the lower cadre and seniority of members of the service promoted under the proviso to clause (c) of sub-rule (1) of Rule 5 of the HJS Rules, 1994, (amended vide L.D.No. F:17(E) 40/88/21-B (one) dated 13-08-2015) shall be fixed in the order of merit they are placed in the selection list.".
