POST GRADUATE IN SUPER SPECIALITY (D.M./M.Ch.)

Preamble

The programme aims at training a Physician in the Specialty of Post Graduate in Super Specialty (D.M./M.Ch.) encompassing the related knowledge, skills and attitudes so as to enable him/her to function as an independent consultant and a teacher well acquainted with research methods in Medical Sciences.

A post graduate student pursuing Super Specialty (D.M./M.Ch.) course must acquire adequate knowledge of (a) Basic Sciences as applied to D.M./M.Ch., as well as (b) recent advances in this field.

1.0 AIM AND OBJECTIVE:

- 1.1 To specialize students in Super Specialty Subjects for higher studies.
- 1.2 To enable utilization of Medical Science/Super Specialty Subjects in various professions.
- 1.3 To train students for advanced studies in Medical Science/Super Specialty Subjects leading to research.
- 1.4 Developing human resource for government organization and Health Sciences field which requires use of scientific techniques.

2.0 APPLICABILITY:

- 2.1 This ordinance shall apply to the programme and courses leading to the award of post graduate degrees of Super Specialties (D.M./M.Ch.).

3.0 DEFINITIONS:

- 3.1 **Academic Year:** Normally a period of 12 months, co-commencing with the programme.
- 3.2 **Course:** An Academic programme and/or component, carrying a distinctive code and specific credits assigned to it.
- 3.3 **External Examiner:** Examiner not in the employment of the University.

- 3.4 Programme:** Programme of courses and/or other components leading to the award of degree of Super Specialties (D.M./M.Ch. in D.M. in Critical Care Medicine/D.M.in Hepatology/D.M.in Neuroanesthesia/D.M.in Neuroradiology/ D.M. in Organ Transplant Anaesthesia and Critical Care/ D.M. in Paediatric Oncology/ D.M. in Paediatric Hepatology/ D.M. in Paediatric Neurology/ D.M. in Virology/ D.M. in Infectious Diseases/ D.M. in Endocrinology/ D.M. in Medical Genetics/ D.M. in Geriatric Mental Health/ D.M. in Pediatric Nephrology/ D.M. in Neonatology/ D.M. in Clinical Pharmacology/ D.M. in Neurology/M.Ch. in Gynaecological Oncology/M.Ch. in Hand Surgery/M.Ch. in Hepato Pancreato Biliary Surgery/M.Ch. in Reproductive Medicine & Surgery/M.Ch. in Vascular Surgery/M.Ch. in Surgical Gastroenterology/M.Ch. in Pediatric Surgery/M.Ch. in Plastic & Reconstructive Surgery.
- 3.5 Regular Student:** A student who is enrolled in a constituent institution for the purpose of obtaining a Degree/Diploma/Certificate/other recognized education credential to receive education on a full-time basis on payment of tuition fee.
- 3.6 University:** People's University, Bhopal, Madhya Pradesh.
- 4.0 ASSESSMENT**
- 4.1 FORMATIVE ASSESSMENT,** during the training programme
- 4.2** Formative assessment shall be continual which will assess medical knowledge, patient care, procedural & academic skills, interpersonal skills, professionalism, self directed learning and ability to practice in the system.
- 4.3** Internal Assessment shall be frequent, cover all domains of learning and used to provide feedback to improve learning; it should also cover professionalism and communication skills. The Internal Assessment should be conducted in theory and practical/clinical examination.
- 4.4 Six monthly assessment during the D.M./M. Ch. training should be based on:**
1. Improvement in theory knowledge
 2. Patient based /Laboratory or Skill based learning
 3. Self directed learning and teaching

Annual formal assessment to be submitted to Dean / Principal, with recommendation from relevant faculty members, as to promotion to second year.

The post graduate examination shall be in two parts and will be as per the details given in Postgraduate medical education Regulations, 2000.

4.5 Scheme of Summative Assessment/University Examination (D.M./M. Ch.)

The Post Graduate examinations shall be in three parts: -

1. **Thesis:** To be submitted by each candidate at least 6 months before the date of commencement of the theory examinations. Candidates will be eligible to appear in Theory and Practical Exams only after approval of Thesis by external examiners and NOC obtaining from Office of COE.
2. **Theory:** Theory Examination will consist of 4 papers: Paper I, II, III & IV of 100 marks each (total of 400 marks) and each of 3 hours duration.
3. **Practicals:** D.M. Endocrine practical examination will consist of 400 total marks.

5.0 ADMISSION AND ELIGIBILITY:

- 5.1 Candidates possessing following minimum qualification shall be eligible for admission: -
- 5.1.1 Post Graduate in respective discipline as per criteria given by National Medical Commission.
- 5.2 Admissions shall be according to the following criteria: -
- 5.2.1 Merit prepared on the basis of qualifying examination/ or test conducted by Medical Council Committee/National Testing Agency or an agency on its behalf.
- 5.3 Last date for admission will be as notified by the Medical Council Committee/National Testing Agency or any agency on its behalf.
- 5.4 Admission of Foreign Nationals / NRI/ PIO shall be as per policy/rules as applicable.

6.0 TRAINING PROGRAMME

- 6.1 The training given with due care to the Post Graduate students in the recognized institutions for the award of various Post Graduate medical degrees / diplomas shall determine the expertise of the specialist and / or medical teachers produced as a result of the educational programme during the period of stay in the institution.
- 6.2 All the candidates joining the Post Graduate training programme shall work as Full Time Residents' during the period of training and shall attend not less than 80% (Eighty percent) of the imparted training during each academic term of 6 months including assignments, assessed full time responsibilities and participation in all facets of the educational process.

7.0 PERIOD OF TRAINING:

- 7.1 The period of training for obtaining these degrees shall be three completed years (including the examination period) after obtaining D.M/M.Ch. degrees, or equivalent recognized qualification in the required subject;

8.0 MEDIUM OF INSTRUCTION:

- 8.1 English shall be the medium of instruction and examinations.

9.0 ATTENDANCE:

9.1 Regular students, to be eligible to appear in the University examination, are required to attend a minimum of 80% for Theory and Practical Both.

10.0 EXAMINATIONS:

10.1 Details of Syllabus, Scheme of Examination and Programme Structure for D.M./M.Ch. degrees programme in shall be prepared and proposed by Board of Studies/Dean Faculty and approved by Academic Council.

11.0 HEAD OF PASSING & PASSING CRITERIA:

11.1 Obtaining a minimum of 50% marks in 'Theory' as well as 'Practical' separately shall be mandatory for passing examination as a whole.

11.2 Student must secure 40% marks in each of the paper with 50% marks in aggregate (all papers together) to pass in the subject.

12.0 APPOINTMENT OF UNIVERSITY EXAMINERS:

12.1 No person shall be appointed as an internal examiner in any subject unless he/she has Three experience as recognized PG teacher in the concerned subject. For external examiners, he/she should have minimum six years of experience as recognized PG teacher in the concerned subject

12.2 There shall be at least four examiners in each subject at an examination out of which at least 50% (fifty percent) shall be external examiners. The external examiner who fulfils the condition laid down in clause – 12.1 above shall ordinarily be invited from another recognized university, one from outside the State: and other within State provided that in exceptional circumstances examinations may be held with 3 (three) examiners if two of them are external and Medical Council of India is intimated with the justification of such examination and the result in such a case shall be published with approval of Medical Council of India.

12.3 An examiner shall ordinarily be appointed for not more than two consecutive terms.

12.4 The internal examiner in a subject shall not accept external examiner ship for a University/Institute from which external examiner is appointed in his subject.

12.5 Where there is more than one centre of examination, there shall be Coordinator/Convener/Chairman who shall be the senior most internal Examiner. appointed by the University and shall supervise and Co-ordinate the examination on behalf of the University with independent authority.

13.0 CANCELLATION OF ADMISSION:

Admission of a student may be cancelled under following circumstances:

13.1 At any stage, if student is not found qualified for the programme, as per norms/ guidelines or the eligibility criteria prescribed by the NMC/University.

13.2 Involvement in gross indiscipline in the University.

14.0 Any Changes thereof by NMC/MCI/Any Other regulatory body that governs, the regulations of D.M./M.Ch. shall be taken In toto after the recommendation of Board of Studies (BOS), Dean Faculty and Approval of Academic Council.

ORDINANCE NO 81

FOR M.D. (Homoeopathy) Course

1. This ordinance is for Post Graduate Degree Course in Homoeopathy/Doctor of Medicine in Homoeopathy/M.D. (Hom.) Course shall be called the M.D. (Homoeopathy) Course Ordinance of Ram Krishna Dharmarth Foundation University, Bhopal.

2. The subjects of specialization for Post Graduate in Homoeopathy M.D. (Hom.) course are as follows:

- (i). Homoeopathic Materia Medica
- (ii). Organon of Medicine and Homoeopathic Philosophy
- (iii). Homoeopathic Repertory and case taking
- (iv). Homoeopathic Pharmacy
- (v). Practice of Medicine
- (vi). Pediatrics
- (vii). Psychiatry
- (viii). Community Medicine
- (ix). Dermatology

The specialization shall be as amended by National Commission for Homoeopathy, New Delhi from time to time and as approved by the Academic Council/Board of Management of University.

3. The course will be of minimum three years duration, including one year house-job, during which the candidate will be resident in the campus and will be trained as per the provisions of the National Commission for Homoeopathy, New Delhi.

Provided, that the candidate must complete the M.D. (Hom.) in a particular subject within the maximum period as per the provisions of the National Commission for Homoeopathy, New Delhi, and as modified from time to time by them.

4. The minimum qualification for any candidate for admission to M.D. (Hom.)

course will be as per the rules of the National Commission for Homoeopathy, New Delhi or Government of India or Government of M.P. or University (whichever is made applicable).

Reservation of seats for students belonging to All India Quota, Scheduled Caste, Scheduled Tribe, Other Backward Classes and other reservation systems will be as per the instructions / guidelines issued by the Government of India / Government of Madhya Pradesh from time to time.

The number of admissions in the course shall be as permitted by the National Commission for Homoeopathy, New Delhi from time to time.

5. The syllabus shall be as prescribed by the National Commission for Homoeopathy, New Delhi for each specialty of the Post Graduate Degree M.D. (Hom.) and approved by the Academic Council of University.

6. The examination shall be conducted as per rules defined by the National Commission for Homoeopathy, New Delhi for individual specialty of Post Graduate Degree M.D. (Hom.) / as approved by the Academic Council/Board of Management.

7. The student will be eligible for appearing in the examination if he/she fulfills the requirement of attendance, fulfills the required fees and assigned work, obtains no-dues certificate and work completion certificate from the competent authority.

8. The process/rules and guidelines for conduction of examination shall be as per National Commission for Homoeopathy, New Delhi, / as approved by competent authority, Ram Krishna Dharmarth Foundation University, Bhopal.

9. A certificate of having completed one year house job in a Homoeopathic hospital shall be an essential part of the course.

10. The minimum attendance requirement for appearing in M.D. (Hom) Part -I and Part -II examination shall be 80%.

11. Every student shall be required to submit the dissertation within the guidelines given by the National Commission for Homoeopathy, New Delhi and under the instructions of the Competent Authority. The dissertation will be valid after approval by the competent authority.

12. Regular teachers of all the concerned departments of the University will be eligible as supervisors (guides) of the students of the concerned department of postgraduate course.

The maximum ratio for allocation of students to guide shall be as under: Vice Chancellor

- (a) If the guide or supervisor is of the rank of Professor, then the student-supervisor (guide) ratio will be 3:1.
- (b) If the guide or supervisor is of the rank of Associate Professor, then the student-supervisor (guide) ratio will be 2:1.
- (c) If the guide or supervisor is of the rank of Assistant Professor, then the student-supervisor (guide) ratio will be 1:1.

The student supervisor (guide) will be from the teaching faculty of the Homoeopathic College/ Department where the concerned student has taken admission.

13. Only Professor, Associate Professor and Assistant Professor will be eligible as supervisors. The qualification of Professor, Associate Professor and Assistant Professor shall be as per the rules of the National Commission for Homoeopathy, New Delhi and as approved by competent authority of University.

14. The eligibility of the co-supervisor (co-guide) will be the same as that of the supervisor (guide). It is not mandatory that the co-supervisor (co-guide) be a regular teacher of the University. Allocation of co-supervisor (co-guide) to a student shall be optional.

15. All academic, training, research activities and other activities will be conducted as per the Curriculum/ Syllabus defined by the National Commission for Homoeopathy, New Delhi for each specialty of the Post Graduate Degree MD (Hom.) course and as per approval of academic council of University.

16. Examiner-

(1) The criteria for appointment of Examiners will be the same as for Supervisor (Guide) or Co-Supervisor (Co-Guide).

(2) Selection, appointment and work of examiners will be in accordance with the guidelines of the National Commission of Homoeopathy, New Delhi and as approved by competent authority, Ram Krishna Dharmarth Foundation University, Bhopal.

17. The Fees of this Course shall be as decided by the Board of Management of the Ram Krishna Dharmarth Foundation University, Bhopal and approval of competent authority, State Government/M.P. Private University Regulatory Commission.

18. The revisions/amendments for Post Graduate M.D. (Hom.) course as amended National Commission for Homoeopathy, New Delhi or Government of India or Government of M.P., shall be implemented on the approval of competent authority, Ram Krishna Dharmarth Foundation University, Bhopal.

19. If any term or statement or matter is not mentioned or defined in the rules and regulations of the National Commission for Homoeopathy, New Delhi or the Ordinance of Ram Krishna Dharmarth Foundation University, Bhopal for the Post Graduate M.D. (Hom.) course or if any discrepancy is found in this Ordinance, then the decision taken by the Vice Chancellor, Ram Krishna Dharmarth Foundation University, Bhopal in the same shall be final and applicable.

20. Any amendment in MD (Hom) regulations/circulars issued by the National Commission for Homoeopathy, New Delhi/ Govt. Of India Department of Ayush/ MP Govt Department of Ayush shall be strictly followed accordingly.

ORDINANCE NO 82

Diploma in Homoeopathy Pharmacy Course

1. This ordinance provides for Diploma in Homoeopathy Pharmacy Course shall be called the Ordinance of Ram Krishna Dharmarth Foundation University, Bhopal.
2. The course will be of minimum two years duration. Provided that the candidate must complete the Diploma in Homoeopathy Pharmacy Course in a particular subject within the maximum period as per the provisions of the M.P. Paramedical Council, Bhopal (M.P.).
3. The minimum qualification and minimum age for any candidate for admission to Diploma in Homoeopathy Pharmacy Course will be as per the rules of the M.P. Paramedical Council, Bhopal (M.P.) or Ram Krishna Dharmarth Foundation University, Bhopal.
Reservation of seats for students belonging to Scheduled Caste, Scheduled Tribe, Other Backward Classes and other reservation systems will be as per the instructions / guidelines issued by the Government of India / Government of Madhya Pradesh from time to time.
The seat intake in the course shall be as prescribed by the Madhya Pradesh Paramedical Council, Bhopal from time to time.
4. The syllabus for the course shall be as defined by the M.P. Paramedical Council, Bhopal (M.P.) / Academic Council of Ram Krishna Dharmarth Foundation University, Bhopal.
5. The examinations for the course shall be as defined by the M.P. Paramedical Council, Bhopal (M.P.) / Ram Krishna Dharmarth Foundation University, Bhopal.
6. The medium of Instructions and Examination shall be English and Hindi.
7. The Fees of this Course shall be as decided by the Board of Management of the University and after the approval of M.P. Private University Regulatory Commission.
8. The eligibility for examination shall be fulfillment of attendance requirement, prescribed fees, completion of assigned work and no-dues certificate and work completion certificate from the competent authority.
9. The minimum attendance requirement towards eligibility for appearing in examination is 75%.
10. All examinations, academic, training, research activities and other activities will be conducted as per the Curriculum/ Syllabus provided by the M.P. Paramedical Council, Bhopal (M.P.) / Ram Krishna Dharmarth Foundation University, Bhopal for the Course.
11. The examination shall be held as per rules and regulations of M.P. Paramedical Council, Bhopal (M.P.), / Ram Krishna Dharmarth Foundation University, Bhopal.
12. The revisions/amendments as approved by M.P. Paramedical Council, Bhopal (M.P.) / Competent authority from time to time shall be implemented on the approval of competent authority of Ram Krishna Dharmarth Foundation University, Bhopal, the same will also be applicable.
13. If any term or statement or matter is not mentioned or defined in the rules and regulations of the M.P. Paramedical Council, Bhopal (M.P.) or the Ordinance of Ram Krishna Dharmarth Foundation University, Bhopal for the Diploma in Homoeopathy Pharmacy Course or if any discrepancy is found in this Ordinance, then the decision taken by the Vice Chancellor, Ram Krishna Dharmarth Foundation University, Bhopal in the same shall be final and applicable.

Subsequent ordinance no. 67

Post Graduate Degree Course in Homeopathy - M.D. (Home.)

This ordinance shall be applicable to candidate admitted for

Post Graduate Course in Homeopathy - M.D. (Home.)

01. Scope:-

- 1.1 To facilitate accessible and affordable quality education that leverages the students with scholarly and professional skills and moral principles in global perspective;
- 1.2 To augment both faculty and student research addressing basic and regional problems;
- 1.3 To integrate a national and international perspective into our fundamental five-fold missions of teaching, research (Patient Care) training and consultancy;
- 1.4 To cultivate adoption of ethics, morality, healthy practice in professional life by installing habit of continual learning;
- 1.5 To explore for knowledge and wisdom in order to build a wealth of academic resources indispensable for a sustainable development to accomplish the status of a leading research-intensive institute; and to engage in transferring of knowledge to the community in order to strengthen and elevate the community potential, and to increase the competitiveness of India in Homeopathy at the global level.

02. Objective of homoeopathy Post-graduate training Programme:-

- 2.1 The objective of homoeopathy postgraduate training programme are as follows, namely:-
- 2.2 recognize the importance of Homoeopathy in context with National priorities and health needs of the community;
- 2.3 Practice Homoeopathy ethically and in step with the principles of the system;
- 2.4 develop skills as a self-directed learner, recognize continuing education needs, select and use appropriate analyses relevant published research literature;
- 2.5 identify social, economic, environmental, biological and emotional determinants of health in a given case, and take them into account while planning therapeutic, rehabilitative, preventive and promotive measures or strategies;
- 2.6 diagnose health problems and manage as per the scope of homoeopathy on the basis of clinical assessment, investigation etc;

- 2.7 demonstrate scientific acumen by undertaking dissertation or research project using proper research methodology;
- 2.8 play the assigned role in the implementation of national health programmes with homoeopathy, effective and responsibly;
- 2.9 organize and supervise the chosen or assigned health care services demonstrating adequate managerial skills in the AYUSH clinic or hospital or in the field; and
- 2.10 develop skills in using educational methods and techniques applicable to the teaching of homoeopathy medical students.

03. Eligibility of Admission :-

- 3.1 No Candidate shall be admitted to M.D. (Hom.) course unless he/she possesses the degree of :
 - 3.2 Bachelor of Homoeopathic Medicine and Surgery or equivalent qualification in Homoeopathy included in the Schedule/Degree Recognition list of the Act, after undergoing a course of study of not less than five years and six months duration including one-year compulsory rotatory internship; or
 - 3.3 Bachelor of Homoeopathic Medicine and Surgery (Graded Degree) or equivalent qualification in Homoeopathy included in the Second Schedule to the HCC Act after undergoing a course of study of not less than two years' duration.
- 3.4 The candidate for M.D. (Hom.) course shall be selected only if they secure minimum of 50th percentile marks in the All India AYUSH Post Graduate Entrance Test (AIA-PGET) examination
 Provided that the said All India AYUSH Post Graduate Entrance Test (AIA-PGET) shall not be applicable for foreign national's candidates.
- 3.5 An All-India common merit list as well as State –wise merit list of the eligible candidates shall be prepared by the designated authority as notified by state quota, and the admission rules of state government based on the marks obtained in the All-India AYUSH Post-graduate Entrance Test conducted for the academic year and the candidate within the respective category shall be considered for admission to post-graduate course from the said merit list.
- 3.6 The counseling shall be organized by directorate of Ayush under the notified rules by state governments per the notification of government of India ministry of Ayush/NCH/State government
- 3.7 The medical institution shall send the final list of admitted students to the Commission, within one month of closure of admission and the Commission shall verify the medical institution to ensure the compliance of the provisions of the regulations at any time.

Further provided that in respect of :-

- (ii) Candidate belonging to the Schedule Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at 40th percentile;
- (iii) Candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45th percentile for General Category and 40th percentile for the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
- (iv) But the amendments made from time to time by the authorized Council/Regulatory Authority, in the rules prescribed for admission to Homeopathy postgraduate course will come into effect with immediate effect.

- 3.8 The registration and enrolment proposal sent by the Dean/Principal/HOD of the constituent Unit of University shall be rejected at any time during the study period, if the admission procedure laid down by the competent authority, rules of the registration and eligibility prescribed by the University are not followed in toto.

04. Reservation:-

Reservation for candidates belonging to Scheduled Castes, Scheduled Tribes & OBC &, as per National Commission for Homoeopathy/Government of Madhya Pradesh directives applicable at the time of admission.

05. Course of study.- (1) Subjects of Specialization for Homoeopathy post-graduate degree course shall be the following, namely:-

- 5.1 Homoeopathic Materia Medica
- 5.2 Homoeopathic Philosophy
- 5.3 Homoeopathic Repertory
- 5.4 Homoeopathic Pharmacy
- 5.5 Practice of Medicine
- 5.6 Pediatrics
- 5.7 Psychiatry
- 5.8 Community Medicine and Public Health
- 5.9 Dermatology,

06. Components of the post-graduate curriculum:-

The post-graduate curriculum shall be set in a competency based integrated framework based on the outcomes defined for each specialty subject. Among other specific constituents, it shall comprise the following, namely:-

- (a) theoretical and applied knowledge;

- (b) practical, clinical, community and management related skills pertaining to the specialty subject;
- (c) completion of dissertation work;
- (d) publication or submission of a research article in peer-reviewed scientific journal or presentation of the paper in the National Conference of the concerned society;
- (e) Soft skills and attributes including interpersonal and communication skills;
- (f) training in Research Methodology, Medical Ethics and Medicolegal aspects;
- (g) professionalism and commitment to continued learning throughout professional life.

07. Duration of the Course:-

7.1 The Duration of M.D. (Hom.) Post Degree Course shall be three years including one year of house job, during which the student shall be a resident in the campus and shall be given training.

7.2 A Student shall complete the Course of M.D. (Hom.) in a speciality subject within the duration of six years from the date of his admission. A student shall stand discontinued as an enrolled student of the university after six years.

7.3 Provided that, One compassionate opportunity may be granted by the Vice-Chancellor, if the student has not failed in more than two subjects (Theory and Practical will be treated as a separate subject). Provided also that the student must have submitted the application for this within a period of one academic year (in continuity).

08. Medium of instruction:-

The medium of instruction and examination (theory, practical, internal, & viva-voce) shall be in English.

09. Scheme of Assessment:-

university shall be follow the scheme of assessment of post-graduate course in homoeopathy as prescribed by national health commission of homoeopathy, new Delhi, Ayush Mantralay New-Delhi and Ayush Mantralay Government of Madhya Pradesh.

The examination for the Post Graduate Degree of:-

- 9.1** Written Examination
- 9.2** Clinical/Practical and Viva Voce Examination
- 9.3** Viva Voce on Dissertation with power point presentation for M.D. (Hom.) Part -I and Part-II Examination.
- 9.4** Scheme of Examination of M.D. (Hom.) Post Degree Course will be prepared and recommended by Board of Study of respective department and approved by Academic Commission.

10. Syllabus :-

University shall be follow the Syllabus of Post Graduate Course in Homeopathy as prescribed by National Commission of Homeopathy, New Delhi during the course.

11. Examination :-**11.1 The Examination shall be conducted in two parts, namely :-**

(a) M.D. (Hom.) Part I, which is to be held six months after completion of house job of one year's duration.

(b) M.D. (Hom.) Part I, which is to be held after one year and six months after part I examination.

11.2 Every candidate seeking admission to part I of the examination shall submit application to the respective department of School of Homoeopathy, with the following documents :

(i) A certificate from the Principal/Head of the Department about the completion of the course of studies in the subjects in which the candidate seeks admission to the examination; and

(ii) A certificate of having completed one year house job in a Homoeopathic hospital as essential of part of the course.

(iii) A certificate from the Guide (Supervisor) of submission of Synopsis within the time prescribed by the respective department of School of Homoeopathy.

(iv) There shall be minimum of 80% attendance to become eligible for appearing in M.D. (Hom.) Part I Examination.

(v) Every candidate seeking admission to the Part II of the examination shall submit a dissertation. The dissertation shall form the basis of viva-voce examination.

(vi) The maximum marks for each subject and minimum required to pass the shall be as prescribed by National Commission of Homoeopathy, New Delhi.

11.3 Viva-Voce/Practical examination in each general subject, to be held by not less than four examiners together out of which one shall be the Supervisor (Guide).

Provided that if all four examiners do not arrive at consensus in assessing a student then a decision taken by three of them shall be final.

11.4 The four examiners shall jointly assess the knowledge of the candidate for recommending the result to the University as passed or failed.

11.5 Each theory examination shall be of three hours duration.

11.6 On recommendation of Principal of School of Homoeopathy, The University shall allow a failed student to reappear in examination within six months.

11.7 A Candidate not passing examination in a subject of part I M.D. (Hom.) course shall reappear in all part of that subject but only one chance to reappear in that subject of examination shall be provided failing which he has to reappear in examination in all the subjects (in all parts of M.D.(Hom.) Part I.

11.8 A candidate shall be declared pass if he/she gets minimum 50% marks each in theory and in Practical/Clinical including Viva-voce examination.

12. Pattern of training:-

- (1) The period of training for obtaining Homoeopathy post-graduate specialty subject shall be three completed years including the period of examination.
- (2) In the Beginning of post-graduate training, there shall be an induction programme for seven days which will comprise of –
 - (a) Orientation about post-graduate course; and
 - (b) workshop in concerned subject specialty with subject experts.
- (3) The post-graduate students shall be called Junior Resident in M.D. (Homoeopathy) part-I and senior resident in M.D. (Homoeopathy) Part-II, in all specialty subject of Homoeopathy post-graduate degree course.
- (4) During the post-graduate course, the emphasis shall be more on clinical training and less on didactic lectures.
- (5) The student should take part in seminars, group discussions, clinical meetings and journal club meetings.
- (6) The student shall be required to write a dissertation as mentioned in regulation 8.
- (7) The student shall be given graded responsibility in the hospital campus in the management and treatment of patients entrusted to his care as per duty roster.
- (8) The student shall participate in teaching and training of under-graduate students or interns.
- (9) The student shall maintain an e-Log Book or Log book and do the laboratory or clinical work keeping in view the needs of each specialty subject.
- (10) A student pursuing M.D. (Homoeopathy) Course shall study in the concerned Department of the institution for the entire period as a regular student. No student is permitted to work in any laboratory or college or industry or pharmacy, while pursuing the Homoeopathy post-graduate degree programme. No student shall join any other regular degree program in any other University in India or Abroad during the period of Homoeopathy post-graduate degree course.
- (11) University Grants commission approved Certificate of Diploma course through open distance learning or online mode may be allowed for post-graduate student for improving various skills with permission of the Head of the institute without disturbing the work or duties assigned for. M.D. (Homoeopathy) course.
- (12) Each year shall be taken as a unit for the purpose of calculating attendance.

- (13) Every student shall mandatorily attend symposia, seminars, conferences, journal club meeting and lectures during each year as prescribed by the Department or college or University and not remain absent without any valid reasons and prior permission of the Head of the Institute.
- (14) A Student who has secured a minimum of seventy five percent. Of attendance and shows satisfactory progress, shall be permitted to appear at M.D. (Homoeopathy) Part-I and Part-II examinations respectively.
- (15) Any student who fails to complete the course in the manner stated above shall not be permitted to appear at the University examinations. A certificate to this effect shall be sent to University by the Principal of the concerned college.
- (16) Every student shall maintain an e-Log Book or Logbook (separately Part-I and part-II) for M.D. (Homoeopathy) and record his participation in the training programmes conducted by the Department such as journal reviews, clinical presentations, seminars.
- (17) The work dairy shall be scrutinized and certified by the Head of the Department and Head of the Institution and presented in the University at the time of practical examination, if called for.
- (18) Special mention shall be made of the presentations by the student as well as details of experiments or laboratory procedures conducted by the student.
- (19) The presentations shall be assessed by the faculty members and peers and assessed on numeric rating scale from 1 to 10.

13. **Synopsis and Dissertation:-**

- (1) Every student shall submit to the competent authority of the University in the prescribed proforma, a synopsis containing particulars of proposed research study within a period of nine months from the date of commencement of the course or before the date notified by the University. They synopsis shall be submitted through the guide, Head of Department of concerned specialty and counter signed by the Head of the.
- (2) Every post-graduate student shall write dissertation about his research study in the format specified by the University, under the supervision of his Guide, and submit to the University, It includes identification of the problem, formulation of research question, hypothesis, review of literature, research methodology including the study design, discussing results and methods of conducting research study, collection of data, statistical analysis and drawing conclusions.
- (3) Every student pursuing M.D. (Homoeopathy) degree course is required to submit six printed copies of dissertation or as required by the concerned University and soft copies, if required, of not less than ten thousand words embodying his own research study to the University for approval, not later than six months prior to holding of M.D. (Homoeopathy) Part-II examination.
- (4) In case of rejection of synopsis, the student has to resubmit the synopsis to the University concerned through his Guide, in any case three months prior to the M.D. (Homoeopathy) Part-I examination.

- (5) The synopsis of the proposed study has to be registered with clinical trials registry of India after obtaining ethical approval from Institutional ethical committee.
- (6) The dissertation should be written under the following headings, namely:-
- (a) abstract;
 - (b) introduction;
 - (c) aim and objectives of study;
 - (d) review of literature;
 - (e) material and methods;
 - (f) observation and result;
 - (g) discussion;
 - (h) conclusion;
 - (i) references; and
 - (j) annexure or appendices.
- (7) The written text of dissertation shall not be less than fifty pages and shall not exceed two hundred pages, excluding references, tables, figures and annexure. It should be neatly typed with double line spacing on one side of the bond paper (A4 size, 8.27" x 11.69") and bound properly. Spiral binding should be avoided. The dissertation shall be certified by the guide and Co-guide (if any), Head of the Department and Head of the Institution.
- (8) A student shall adhere to plagiarism policy and the copyright Act, 1957 (14 of 1957) as amended from time to time, and give an undertaking in writing for the same.
- (9) The dissertation shall be submitted to the guide at least three months before the time fixed for submitting it to the University. The guide or supervisor shall certify that the contents of the dissertation are the original work of the candidates and has not been submitted to any other. University for the award of any degree or diploma. The student, whose dissertation has not been accepted by the University may be permitted to resubmit the same within a period of three months prior to M.D. (Homoeopathy) Part-II examination.

14. Student Guide Ratio:-

- (a) Supervisor (Guide) ratio shall be 3:1 if the Guide is Professor cadre
- (b) Supervisor (Guide) ratio shall be 2:1 if the Guide is Associate Professor cadre.
- (c) Supervisor (Guide) ratio shall be 1:1 if the Guide is Assistant Professor cadre.

15. Educational Qualification and Experience of Supervisor (Guide):-

- (a) A person shall possess the recognized post graduate degree qualification and experience as laid down in National Commission of Homoeopathy regulation and its amendment from time to time.
Provided that the supervisor (Guide) of a specialty shall remain the supervisor for that specialty only.
- (b) Educational Qualification and Experience for selection of co- Supervisor (Co-Guide):

The Co- Supervisor shall be a Post Graduate teacher in school of Homoeopathy, sssutms, having teaching experience of seven years.

16. Award of Division:-

The minimum marks required to pass in each subject shall be 50% (written, practical & Viva-Voce separately).

The final results shall be declared after taking into account the marks obtained by the candidate in all the examination & candidates who obtain 75% or more marks have passed in the first attempt all the examinations within the normal period of instructions shall be declared to have passed with distinction. The Candidate who obtained 65% or more but less than 75% placed in First Division & who obtained 50 % or more but less than 65% Placed in Second Division.

or

Successful candidates award the pass division and distinction as per the norms/regulation of National Commission of Homoeopathy, New Delhi.

17. Merit List :-

In the notification declaring the result of the final examination for the MD (Hom.) the names of first top 3 rank candidates in order of merit shall be notified by the University securing at least 80% of marks and passing all examination in single attempt.

18. Notwithstanding anything stated in this Ordinance, for any unforeseen issues arising, and not covered by this Ordinance, or in the event of differences of interpretation, the Vice-Chancellor may take a decision after obtaining , if necessary, the opinion/advice of a Committee consisting of any two or all the Head of the Department of School of Homoeopathy, SSSUTMS. The decision of the Vice-Chancellor shall be final.

(As per the " Guidelines for Multiple Entry and Exit in Academic Programmes offered in Higher Education Institutions" issued by UGC, New Delhi under National Education Policy 2020).

Bachelor of Hotel Management and Catering Technology (BHMCT) is a three/four year program designed to prepare students for successful careers in the hospitality industry. Students in this program develop an understanding of the principles of hospitality, food and beverage management, housekeeping and front office management. The program also covers areas such as customer service, marketing, finance, accounting, and organizational behavior. Additionally, the program provides students with hands-on experiences to gain practical skills in areas such as event planning and food preparation and service.

The curriculum of the BHMCT program consists of a combination of both theoretical and practical teaching. In the theoretical courses, students are taught subjects such as management principles, economics, Accountancy, hospitality law, and hotel design. In the practical courses, students get to apply their theoretical knowledge by engaging in activities such as food service, event planning and hospitality operations. Additionally students get to gain valuable work experience through internships and field trips.

1. **Title of the Degree:** Three/four years Undergraduate Degree (CBCS/Semester Mode)
2. **Faculty Name:** Management.
3. **Course Name:** Bachelor of Hotel Management and Catering Technology (BHMCT)
4. **Eligibility Criteria for Admission:** Candidate seeking admission in BHMCT courses must have passed basic eligibility criteria i.e. 5+3+3+4 (NEP-2020 system) or 10+2 (Old system) or any other state /central government Board equivalent system with any stream. Further, candidate appeared in the qualifying examination and awaiting the result may also apply and may be admitted provisionally. But the admission shall be confirmed only after the declaration of the result and passing the examination and fulfilling the admission eligibility criteria within 30 days of admission.
 - 4.1. The last date for admission will be as notified by the University.
 - 4.2. **Mode of Selection:** On the basis of the merit in qualifying examination or policy decided by the competent authority / statutory body of University.
 - 4.3. **Reservation:** As per guideline of MP State Government / statutory body of University.

- 4.4. Eligibility for admission to NRI/other privileged candidates:** Non-resident Indian and other privileged candidate shall be eligible for admission to this course in accordance with the directives of Govt. of India and/or State Government.
- 5. Intake and fees:** The intake and fee for the course shall be decided by the Board of Management of the University from time to time subject to approval of the concerned Regulatory Body.
- 6. Duration of the Course:** The minimum duration of the undergraduate degree programme shall be of three (3) academic years/six {6} semesters. Whereas that of undergraduate degree leading to the Honours/research shall be of four {4} academic years/ eight {8} semesters. (Level 4 is Optional)
- (i) A student who leaves the course anytime in the middle of the programme will retain the credits earned so far, which will be restored/transferred when he/she enters the programme again.
- (ii) The maximum duration for completing the Undergraduate Degree or Undergraduate Degree (Honour's/Research) programme for regular students shall be 6 or 8 Semesters, respectively; there shall be no such bar for non-collegiate (private) Students.
- 7. Entry and Exit System:** The Enable Multiple entry and exit points in the academic programme. Qualifications such as certificate, diploma, and degree shall be organized in a series of levels in an ascending Order from level I to level 4. Level I represents certificate and level 4 represents Bachelor Degree (Honour's/Research) qualification. (Table 1)

Qualification and Credit Requirements are given in Table I. The entry and exit options for students, who enter the undergraduate programme, are as follows.

1st year (First & Second Semester-Level 1)

Entry-1: The entry requirement for first semester in Level I is successful completion of Class 12 from any board recognized by the State/Central Government. A programme of study leading to entry in to the first year of the Bachelor's degree is open to those who have met the admission requirements.

Exit-1: If a student's passes all the courses of Level I and earns the requisite number of credits, the students will become entitled to "an Undergraduate certificate in the faculty of her/his Major Subject. If students want to exit, he/she can exit the programme with Undergraduate certificates in hand.

2nd Year (Three & Four Semester-Level 2)

Entry-2: The entry requirements for third semester in Level 2 is the successful completion of Level 1 A programme of study leading to the second year of the Bachelor's degree is open to those who have met the admission requirements.

Exit-2: If a student passes all the courses of Level 1 and 2 and earns the requisite number of credits, the student becomes entitled to Undergraduate Diploma in the faculty of his/ her major subjects. If the students went to exit, he/ she can exit the program with undergraduate diploma in hand.

3rd Year (Fifth & Sixth Semester Level3)

Entry-3: The entry requirement for semester fifth in Level 3 is successful completion of Level 2. A programme of study leading to the Bachelor's degree is open to those who have met the admission requirement.

Exit-3: If a student passes all the courses of Level I to 3 i.e. first to six semesters and earns the requisite number of credits, the student becomes entitled to the UG Degree of her/his Major Subject. A Bachelor's degree requires 120 credits from level I to 3. With 40 credits level 1, 40 credits at level 2. And 40 credits at level 3.

4th Year (Seventh & Eight Semester-Level 4-Optional)

Entry-4: An individual seeking admission to a Bachelor's degree in Honour's/Research (Level 4) in a specified field of learning would have completed all requirements of the relevant three-year bachelor degree (level 3) After completing the requirements of a three-year Bachelor's degree. Candidates who meet a minimum CGPA / credit shall be allowed to continue studies in the fourth year of the undergraduate programme to pursue and complete the Bachelor's (Honour's/Research) Degree.

Exit-4: If a student's passes all the courses of Level I to IV and earns the requisite number of credits, the student becomes entitled to the UG Degree (honour's/Research) in the faculty of her/his Major Subject A Bachelor's degree (Honour's /Research) requires a total of 160 credits from level I to IV with, 40 credits at level I, 40 credits at level II, 40 credits level III, and 40 credits at level 4.

- 8. The Examination Scheme:** Generally, each course will correspond to an examination paper (Online if needed) comprising of external and internal evaluations. First semester end theory examinations for Major, Minor, Generic and DS will be 3 hours while vocation (SEC) and Ability Enhancement Course (AEC) will be 2 hours duration.

Examination will be conducted as per the scheduled decided by the Board of Management of the University from time to time. Subject to approval by the concerned regulatory body. Regulations made in this respect as described in the Scheme of examination promotion to

subsequent semesters and course of studies shall be as per the recommendation of the concerned Board of Studies with due approval of Academic Council. The Examination pattern shall be CRCSI with continuous assessment of students. The passing criteria will be 50% including internal exam for both theory and practical separately. The Studies and examination of the course shall be on the basis of marks/marks cum credit/credit system as recommended by university from time to time. "

8.1. There shall be One University Examination at the end of each semester. These examination will be designated as follow :

- During Ist year: BHMCT Ist & IInd Semester.
- During IInd year : BHMCT IIIrd & IVth Semester.
- During IIIrd year : BHMCT Vth & VIth Semester.
- During IVth year : BHMCT VIIth & VIIIth Semester.

8.2. Retotaling and Revaluation will be applicable as per Sri Aurobindo University Examination Ordinance.

8.3. Medium of instruction: The Medium of Instruction during the Examination shall be English/Hindi.

8.4. Attendance Requirement: A candidate must have at least 75% attendance in each semester, provided that, in case of illness or because of other reasonable cause, it shall be relaxed by Vice Chancellor as up to 15% admissible within applicable regulation.

9. Credit System: The four- year undergraduate programme shall comprise courses under the following subjects/Categories.

The credits will be awarded by the University. The credit can be calculated as follow.

- * One hour of theory or one hour of tutorial or two hours of laboratory work per week for 15 weeks resulting in the award of one credit.
- * Credits for internship shall be one credit per week of training. Subject to a maximum of six credits in a semester.

10. For Passing a semester examination and for promotion to the next semester (from Ist to 8th Semester) a student shall have to obtain a minimum of 50% marks in each paper separately of theory and Practical Examinations including dissertation/thesis/ project work (wherever applicable) The division shall be declared on the basis of total marks scored in all the six semesters as follows.

75% or more marks	First division with Honour's.
60% or more marks	First division.
50% are above but less than 60% marks	Second division, where students score.

If any candidate failed to earn minimum required number of credit in exam/practical/training from any institutions in particular level to promote next level, University can conduct special exam so he/she can reappear in that particular exam/practical/training to earn required minimum no of credits to promote next level.

11. **Types of Courses:** Courses are the basic units of education and or training type of course shall be as follow.

- **Core Course:** Such courses which shall compulsorily i.e. studied by the student as core requirements of the programme.
- **Elective Course:** Generally, a course which the student can choose from a pool of courses. Which is specific or specialized at advanced or supportive to the discipline/subject of study or which provides an extended scope or which enables or skill is called an Elective Course?
 - Discipline Specific Elective (I) SE Course.
 - Dissertation/Project
- **Generic Elective (GE) Course:** An elective course chosen generally from an unrelated discipline/subject to seek exposure of another field is called a Generic Elective course.

12. **Ability Enhancement Course (AEC):**

- The Ability Enhancement Course (AEC) are of two types
- Ability Enhancement Compulsory Courses (AECC)

ORDINANCE NO. - 76**Master of Hotel Management and Catering Technology (MHMCT)**

(As per the " Guidelines for Multiple Entry and Exit in Academic Programmes offered in Higher Education Institutions" issued by UGC, New Delhi under National Education Policy 2020).

The Master of Hotel Management and Catering Technology is a One/Two year Post Graduate Degree Programme which is meant for Graduate students from Hotel Management who are aspiring to work in the hospitality industry or striving towards the higher goals in the world of academics, hotel industry and hospitality industry.

The program provides in-depth knowledge about the advance study that includes; Food & Beverage production and service, Room division management, bar operations etc. hence expanding the abilities and skills of the students about Hospitality trade.

1. **Title of the Degree:** One/Two years Post Graduate Degree (CBCS/Semester Mode)
2. **Faculty Name:** Management.
3. **Course Name:** Master of Hotel Management and Catering Technology (MHMCT)
4. **Eligibility Criteria for Admission:** Candidate seeking admission in MHMCT courses must have passed three/four years Diploma/ Under Graduate Degree in Hotel Management and Catering Technology or Hospitalities Management/ equivalent Graduate Degree from a recognized University.
 - 4.1. The last date for admission will be as notified by the University.
 - 4.2. Mode of Selection: On the basis of the merit in qualifying examination or policy decided by the competent authority / statutory body of University.
 - 4.3. Reservation: As per guideline of MP State Government / statutory body of University.
 - 4.4. **Eligibility for admission to NRI/other privileged candidates:** Non-resident Indian and other privileged candidate shall be eligible for admission to this course in accordance with the directives of Govt. of India and/or State Government.

- 5. Intake and fees:** The intake and fee for the course shall be decided by the Board of Management of the University from time to time subject to approval of the concerned Regulatory Body.
- 6. Duration of the Course:** The minimum duration of the Post Graduate Degree programme shall be of Two (2) Academic years/four {4} semesters. Whereas that of post graduate degree leading to the Master Programme shall be of one {1} academic years/two {2} semesters. (Level 4 is mandatory)

Candidates who meet a minimum CGPA / credit shall be allowed to continue studies in the Second year of the Post graduate programme to pursue and complete the Mater (Honour's/Research) Degree.

Exit-6: If a student's passes all the courses of Level 5 to 6 and earns the requisite number of credits, the student becomes entitled to the PG Degree (honour's/Research) in the faculty of her/his Major Subject A Master degree (Honour's/Research) requires a total of 80 credits from level 5 to 6 with, 40 credits at level 5. 80 credits at level 6, 40 credits level 6.

8. The Examination Scheme: Generally, each course will correspond to an examination paper (Online if needed) comprising of external and internal evaluations. First semester end theory examinations for Major, Minor, Generic and DS will be 3 hours while vocation/skill Enhancement Course (SEC) and Ability Enhancement Course (AEC) will be 2 hours duration.

ORDINANCE NO. 77**DIPLOMA IN HOTEL MANAGEMENT & CATERING TECHNOLOGY
(DHMCT)****In Various streams of Hotel Management & Catering Technology**

 - 4.1) One and Half Year Diploma Program shall be quoted simply 'Program' hereafter in this ordinance, subject to the recommendation of the respective Board of Studies and as per norms of the concerned Regulatory Authority.
 - 4.2) The Board of Studies is authorized to recommend further additions/alterations in this Ordinance with the approval of MPPURC and Government of M.P.
 - 4.3) The diploma will include areas of study / subject / specialization as recommended by the Academic Council and concerned Board of Studies of the University.
 - 4.4) The one and Half year Diploma program will be governed by the rules and regulations of the concerned regulatory authority.

ORDINANCE NO. 81
2 Years Nurse Practitioner in Critical Care (NPCC)
Post Graduate Residency Programme

The government recognizes significant expansion in tertiary care services both in public and private health sectors. In building their capacity, it is highly significant that the health care professionals require advanced educational preparation in specialty and super specialty services. To support specialized and super-specialized healthcare services, specialist nurses with advanced preparation are essential. Developing training programs and curriculum in the area of tertiary care is recognized as the need of the hour. Nurse practitioners (NPs) will be able to meet this demand provided they are well trained and empowered to practice.

Nurse practitioners in critical care / acute care, oncology, emergency care, neurology, cardiovascular care, anesthesia and other specialties can be prepared to function in tertiary care settings.

A curricular structure / framework is proposed by INC towards preparation of Nurse Practitioner in Critical Care (NPCC) at Masters Level. The special feature of this program is that it is a clinical residency program emphasizing a strong clinical component with 15% of theoretical instruction and 85% of practicum. The NP program is a Nursing residency program with a main focus on Competency based training.

1- AIM / OBJECTIVES

The critical care NP program prepares registered BSc nurses for advanced practice roles as clinical experts, managers, educators and consultants leading to M.Sc. degree in critical care NP

On completion of the program, the NP will be able to

1. Assume responsibility and accountability to provide competent care to critically ill patients and appropriate family care in tertiary care centers
2. Demonstrate clinical competence / expertise in providing critical care which includes diagnostic reasoning, complex monitoring and therapies
3. Apply theoretical, patho-physiological and pharmacological principles and evidence base in implementing therapies / interventions in critical care
4. Identify the critical conditions using differential diagnosis and carry out treatment/interventions to stabilize and restore patient's health and minimize or manage complications independently or collaboratively as a part of critical care team

5. Collaborate with other health care professionals in the critical care team, across the continuum of critical care

2- Course and Faculty

Nurse Practitioners in Critical Care (NPCC) Post Graduate Residency Programme shall consist of Two academic years. This Programme is Qualifying Degree for Consultant Leading to M. Sc. Degree in Critical Care.

NPCC Post Graduate Residency Programme shall be run by the faculty of Nursing after getting the approval of Indian Nursing Council (INC).

3- Duration

NPCC Post Graduate Residency Programme shall comprise course of study spread over a period of two years and candidate will have to be a full time student. Maximum no. of attempt will be two and the candidate will be allowed to complete the programme within four years.

4- Intake and fees

The intake shall be decided on the recommendation of Board of Management (BOM) of the University and approved by the INC.

The fees of the course shall be decided by the Board of Management (BOM) of the University from time to time subject to the approval of MPPURC, Bhopal.

5- Eligibility for Admission

Candidate seeking admission to the two years course of NPCC Post Graduate Residency Programme must have passed the Post. Basic B. Sc. Nursing/B. Sc. Nursing or equivalent examination and secure the aggregate marks or grade not less than 50% off total marks.

The candidate should have minimum one year work experience and registered under the INC/MP Nursing Council.

6- Criteria for Selection

The selection of candidate, who fulfill the academic qualification as mention in Column 5 (Eligibility for Admission), shall be based on the merit of the entrance examination conducted by the University or competent authority.

Counselling will be held to finalize the Admission as per the required Ordinance and candidate must be physically present at the time of Counseling, if required

The reservation for the candidate shall be as per University/State Govt. Norms.

7- Course Curriculum

The course curriculum of the NPCC Post Graduate Residency Programme shall be approved by the concerned Board of Studies (BOS) and the Academic Council of the University as per the prescribed guidelines of Indian Nursing Council (INC).

8- EXAMINATION REGULATION

8.1 The medium of instruction & examination shall be English/Hindi through out the Course.

संशोधन

वन्यजीव (संरक्षण) नियम, 1974 के नियम-34 (असाधारण मध्यप्रदेश राजपत्र, दिनांक 27 अगस्त, 2021 द्वारा संशोधित एवं प्रकाशित) के उपनियम 6(6) के नीचे उपनियम 6(7) जोड़ा जाता है :—

F 14-82-1988-X-2.—In exercise of the powers conferred by sub-section (1) and clause (h) of sub-section (2) of Section 64, read with Section 28 of the Wildlife (Protection) Act, 1972 (53 of 1972), the State Government, hereby, makes the following amendments in the Madhya Pradesh Wildlife (Protection) Rules, 1974, namely :—

AMENDMENTS

Sub-rule 6(7) is added below sub-rule 6(6) of Rule 34 of the wildlife (Proection) Rules, 1974 (amended and published by the Madhya Pradesh Gazette, Extraordinary dated 27th August, 2021) as follows :—

Sub-rule 6(7) : All cancelled permits will be available to Indian citizens at the amount corresponding to the Premium Day and at twice that amount for foreign citizens, through MP Online, up to seven days prior to the Safari Day. Tourists can reserve and obtain them. Any permits cancelled within seven days of the Safari Day will be reallocated to the Field Director's quota as per the earlier system.

This amendment will come into force from the date of their issue.

क्र. 855-एफ-2-01-2018-एक-उनसठ.—राज्य सरकार, एतद्वारा, मध्यप्रदेश राजपत्र अधिसूचना के एफ-02-01-2018-1-उनसठ, दिनांक 10 दिसम्बर 2021 को अधिक्रमित करते हुए मध्यप्रदेश आयुष विभाग (राजपत्रित) सेवा भर्ती नियम, 2013 के नियम "सीधी भर्ती की पात्रता की शर्तें" एवं नियम-11 "प्रतियोगी परीक्षा द्वारा सीधी भरती संबंधी नियमों" के नीचे निम्नानुसार संशोधित प्रविष्टि प्रतिस्थापित करती है :—

नियम-11 में उपनियम (IX) में निम्नलिखित उपनियम जोड़े जाये,—

(अ) “विभाग के सीधी भर्ती के नियमित पद के समकक्ष संविदा पदों पर 05 वर्ष की निरंतर सेवा पूर्ण करने वाले संविदा अधिकारियों की कुल संख्या के 50 प्रतिशत पद अथवा विभाग में सीधी भर्ती के रिक्त पद के 50 प्रतिशत तक के पद (दोनों में से जो कम हो) संविदा अधिकारियों की नियुक्ति के लिए आरक्षित रखे जाएंगे. इन निर्देशों के अंतर्गत आरक्षण सुविधा का एक बार लाभ देकर नियुक्ति प्राप्त कर (ज्वाइनिंग) उपरांत पुनः लाभ की पात्रता नहीं होगी.”

(ब) “इस आरक्षण का लाभ प्राप्त करने के लिए निम्न संविदा सेवक पात्र होंगे.—

1. विभाग में नियमित भर्ती के रिक्त पद के समकक्ष संविदा पद पर आवेदक न्यूनतम 05 वर्ष तक निरंतर संविदा आधार पर नियुक्त रहा हो. संविदा पद से नियमित पद की समकक्षता का निर्धारण राज्य शासन द्वारा किया जाएगा. 05 वर्ष की यह अवधि रिक्त पद के विरुद्ध आवेदन करने की दिनांक पूर्ण होना चाहिए. इस आशय का प्रमाण-पत्र उसे प्रस्तुत करना होगा. यह प्रमाण-पत्र यथास्थिति जिला अथवा राज्य स्तर के समकक्ष अधिकारी द्वारा जारी किया जाएगा.
2. सेवा नियमों में प्रश्नाधीन नियमित पद के लिये निर्धारित शैक्षणिक अर्हता तथा अन्य सुसंगत अनुभव जो वांछित है उन्हें वह पूर्ण करता हो.
3. यदि किसी संविदा अधिकारी ने एक ही संविदा पद पर कार्य न करते हुए विभिन्न संविदा पदों पर कार्य किया है तो 05 वर्ष की उपरोक्त अवधि की गणना पूर्ण होने पर वह उस श्रेणी के नियमित पद पर नियुक्ति के लिए आवेदन कर सकेगा; जो राज्य शासन द्वारा नियमित पद के समकक्षता निर्धारण के पश्चात् 05 वर्ष की अवधि में निम्नतम श्रेणी का रहा हो.
4. अगर किसी संविदा अधिकारी को संविदा पद से किसी अवधि में हटा दिया गया हो तथा उसे पुनः उसी पद पर अथवा किसी अन्य पद पर संविदा पर नियुक्ति प्राप्त हो गई हो तो 05 वर्ष की संविदा सेवा अवधि की गणना सेवा से पृथक् रहने की अवधि को घटा कर की जाएगी.
5. किसी भी विभाग में कार्यरत संविदा पर नियुक्त अधिकारी के द्वारा आयुष विभाग द्वारा विज्ञप्त पद पर आवेदन कर सकेगा जो नियमित पद हेतु समकक्षता एवं अर्हता रखता हो.
6. नियमित नियुक्ति होने की स्थिति में संविदा अधिकारी को पूर्व की संविदा सेवाओं का किसी प्रकार का लाभ प्राप्त नहीं हो सकेगा.
7. संविदा अधिकारी के लिए आरक्षित किए गए नियमित पदों पर भर्ती की पारदर्शी एवं प्रतिस्पर्धात्मक प्रक्रिया के माध्यम से चयन किया जाएगा इस हेतु नियुक्तकर्ता विभाग द्वारा न्यूनतम कटऑफ अंक निर्धारण किया जा सकेगा.
8. संविदा अधिकारी एक अथवा एक से अधिक प्रकार के संविदा पदों पर नियुक्त रहा हो सकता है. ऐसी स्थिति में संविदा पद के जिस समकक्ष नियमित पद पर वह नियुक्ति हेतु आवेदन करता है, उसके बराबर या उच्चतर संविदा पर वह जितने वर्ष कार्यरत रहा, उतने वर्ष की छूट उसे निर्धारित अधिकतम आयु सीमा में मिलेगी. आयु संबंधी समस्त छूट सम्मिलित करते हुए संविदा अधिकारी की अधिकतम आयु 55 वर्ष से अधिक नहीं होगी.
9. संविदा अधिकारियों के लिए समकक्ष नियमित पदों पर नियुक्ति हेतु आरक्षित वे पद उस स्थिति में अन्य उम्मीदवारों से भरे जायेंगे जिन पदों को भरे जाने के लिए विहित पारदर्शी एवं प्रतिस्पर्धात्मक प्रक्रिया के पालन उपरांत पर्याप्त संख्या में संविदा अधिकारी अंतिम रूप से चयनित अथवा उत्तीर्ण नहीं हो पाते. संविदा अधिकारियों / कर्मचारियों के लिए आरक्षित पद रिक्त रहने की दशा में कैरी फारवर्ड नहीं किए जाएंगे.
10. नियमित पदों के विरुद्ध नियुक्ति की प्रक्रिया में अनुसूचित जाति / जनजाति / पिछड़ा वर्ग / आर्थिक रूप से कमजोर वर्ग के आरक्षण नियमों का पालन सुनिश्चित किया जाएगा.
